The Warrenton Police Department “Citizen Ride-Along Program” is a component of the department’s community oriented policing strategy focused on fostering opportunities for our citizens to become more familiar and understanding of the role our police officers play in the community. The “Ride-Along Program” provides an opportunity for you to spend some time with a police officer as he/she goes about their duties providing police services to our town. You will ride with the officer, observe them as they engage in activities such as: calls for service response, traffic monitoring and enforcement, criminal investigations and public order control. While we believe this experience is one you will enjoy and learn more about policing and our community as a whole, there are some safety rules we must ask you to follow, in order to provide for your safety and that of the officer you are with:

All persons participating in the “Ride-Along Program” must be at least eighteen (18) years of age. Written approval from the Chief of Police and signed parental waivers will be required for anyone under eighteen (18).

- You must at all times adhere to the instructions that the officer gives you.
- You shall not bring any type of weapon whatsoever with you on the ride-along. You will be asked by the officer if you have any weapons in your possession and if so, you will not be allowed to participate in the program.
- All ride-along participants shall be in proper neat and clean attire. Shorts, T-Shirts and baseball caps are not allowed. “Business Casual” is recommended.
- Any ride-along participants that fails to adhere to the instructions of the police officer he/she is riding with shall be returned to the police station and shall not be allowed to participate in the “Ride-Along Program” in the future.
- A person is not permitted to participate in the Ride-Along Program **more than once within 60 days period** unless special authorization is received from the Chief of Police or designee.
- The Police Department has the right to refuse any person to participate in the “Ride-Along Program” without cause.
- **Must sign page 4 of 5 in the presence of Warrenton Police Officer/Staffer.**
- Completed **application including Attachment A** must be **hand delivered to Warrenton Police Department**, 333 Carriage House Lane, Warrenton at least **(7) days prior to the expected Ride-Along**, Monday-Friday, 8:00 am – 4:30 pm.
- Ride-along participants shall provide their own refreshments and/or snacks.

- No Ride-Along SHALL extend past 2:00 am on Nightshift Ride-Along.

Instructions to Ride-Along Applicants:

Applicants must meet one of the following criteria to participate in the Ride-Along program:

1. Be a representative of business or civic group.
2. Any applicant for a sworn Police Officer position of the Warrenton Police Department, any Sworn Law Enforcement Officer from a certified agency in or out of the Commonwealth of Virginia.
3. Resident of Fauquier County (excluding sworn law enforcement personnel). Non-Residents may be eligible on a case-by-case basis.
4. At least 18 years of age.
5. An approved college student intern.
6. A member of the Office Chaplain's Program.

Ride-Along Program Rules and Regulations

1. All applicants must have a good record (criminal and traffic) and be of good character.
2. A person is not permitted to participate in the Ride-Along Program **more than once within 60 days** period unless special authorization is received from the Chief of Police or designee.

3. All Ride-Along participants are required to conduct themselves in a mature, professional manner at all times.
4. All Ride-Along participants will meet the Patrol Division shift supervisor at **least 15 minutes prior to the scheduled time of the Ride-Along** at the Warrenton Police Department, 333 Carriage House Lane, Warrenton, Va. 20186.
5. The shift supervisor will designate with whom the applicant will ride. The shift supervisor may terminate the participant's Ride-Along at any time, if in his/her opinion, the continued participation presents an undue risk, or the participant's conduct, deportment, or sobriety is such that continued participation is not in the best interests of the Warrenton Police Department.
6. The Ride-Along program shall be conducted at times which have been approved in advance. These time limits may be terminated at the request of the applicant. Extensions of Ride-Along time limits may only be made with the approval of the shift supervisor or their supervisor.
7. Ride-Along participants are prohibited from carrying with them, during the Ride-Along, any flashlight, camera, radio of any type, tape recorder, or player, binoculars, any similar device unless specifically authorized by the Patrol Division Commander, Chief of Police, or designee. Cell phones are permitted but may not be used to record audio or video or take pictures during the ride along.
8. Participants will not be permitted to carry weapons or restraining devices of any kind. Exceptions may be made for law enforcement officials authorized by the Virginia Code.
9. Ride-Along participants are prohibited from using any type of tobacco product during the course of the Ride-Along.
10. Participants are observers. They will not exit the vehicle during any law enforcement activity unless directed to do so by the Police Officer. They will refrain from direct involvement in the functions or conversation with violators, suspects, arrestees, witnesses, complainants, or other members of the public encountered during the course of the official duties of the Police Office with whom the participant is riding.
11. Participants may be asked to temporarily interrupt their Ride-Along during hazardous or unusual circumstances. Participants will immediately comply with such requests and otherwise obey the directions of the Police Officer with whom the participant is riding.
12. During the course of the Ride-Along, the participant may be exposed to privileged information. The participant WILL NOT divulge any of the privileged information.
13. Participants are required to dress in business casual attire during their Ride-Along. No open toe shoes or sandals are permitted.
14. Participants who are family members of the Warrenton Police Department will not ride with the Officer whom they are related to.

I understand that at the sole discretion of the Warrenton Police Department a background check may be conducted prior to being approved for a ride-along.

I agree to comply with all rules and regulations of the Ride-Along Program and any instructions or orders issued by members of the Warrenton Police Department in connection with the Ride-Along Program.

Full Release of All Claims

It is understood that this Release gives the Releaser no authority to act as a law enforcement officer or as any employee or agent of the Town of Warrenton, VA and the Town may, at any time at its sole discretion, terminate the Releasers privileges as set forth herein.

This Release contains the entire agreement between the parties hereto and the terms of this lease are contractual and not a mere recital, and that the experience of said ride along is sufficient consideration in support of this agreement. Releaser further states that he/she has read the foregoing Release and knows the contents thereof and has signed this Release as his/her own free act.
